<u>AREA OF CONSIDERATION</u>: This is a commissioned officer position and is open to commissioned officers within the Maryland Air National Guard.

ELIGIBILITY: Lieutenant Colonel or Colonel-eligible (Air War College enrolled or complete).

POSITION DESCRIPTION:

Ensures collaborative and cohesive integration of the Aerospace Medicine Enterprise resources to provide comprehensive force health protection and medical readiness; occupational and environmental health program compliance; aircraft mishap response; and manage the deployment availability review process and perform deployment related health assessments. Work closely with the full-time Title 5 physician to complete physical exams and reviews for deployment availability, medical evaluation boards, and waivers. Support the 175th Wing and Group Commanders to achieve Wing mission needs.

DUTIES AND RESPONSIBILITIES:

Oversees the Aerospace Medicine Enterprise within the 175th Medical Group and the Aerospace Medicine Council. Evaluates, solves, and up-channels issues of Aerospace medicine Enterprise. Implements effective changes to promote 175th Wing Individual Medical Readiness (IMR) and Physical Evaluation Board (PEB)/Medical Evaluation Board (MEB) compliance. Conduct an effective Airman Medical Readiness Optimization (AMRO) board including analysis of predictive and trailing indicators and performance metrics. Ensure compliance with Deployment Related Health Assessments. Ensure coordination and proper use of preventative medicine resources to ensure mission medical readiness. Provide professional expertise on medical standards, physical qualifications, resolving problems, training, and documenting medical records. Provide oversight of the resources and activities of the Occupational and Environmental Health Working Group to maintain a safe and healthy workplace. Oversee the Flight and Operational Medicine Program and ensure compliance with and maintain mishap response kits and plans for an effective response. Allocate staffing resources appropriately to support the 175th Wing mission. Must have strong oral and written communication skills. See AFI 44-153 for further descriptions of what will be expected of the Chief of Aerospace Medicine.

MANDATORY: Applicants must be a current O-5 or O-6 eligible. Applicants must have a 48R3 AFSC.
