QUALIFICATIONS REQUIREMENTS

1. Group Commander experience is preferred.

FOR AWARD AND RETENTION OF THIS POSITION

1. ANY AFSC may apply: Applicant must meet the basic eligibility requirements specified in the Air Force Officer Classification Directory (AFOCD) 30 APR 2025.
2. Working knowledge of leadership skills and operational employment concepts is mandatory. The following training is mandatory as indicated.
3. The following are mandatory as indicated: Specialty requires routine access to Tier 5 (T5) information, systems or similar classified environments. For award and retention of AFSC 10C0, completion of a current T5 Investigation IAW DoDM 5200.02_AFMAN 16-1405, Air Force Personnel Security Program
4. Note: This position may be filled as a DSG or a full-time MD State Employee using this announcement.

POSITION DESCRIPTION

Commands the Maryland Air National Guard (MDANG), responsible for its full-spectrum readiness, strategic planning, and employment in support of assigned federal and state missions, including Defense Support to Civilian Authorities (DSCA) missions. Serves as a key deputy to the Adjutant General (TAG) and the principal advisor on Air Guard matters, acting with full delegated authority when required. Core functions include guiding force modernization and representing TAG at legislative meetings and other high-level engagements to foster strategic partnerships ensuring the MDANG remains a combat-ready and community-integrated force.

CONDITIONS OF EMPLOYMENT

Individuals selected must meet the Preventative Health Assessment (PHA)/physical qualifications outlined in AFI 48-123, Medical Examination and Standards. They must also be current in all Individual Medical Readiness (IMR) requirements to include immunizations. The Air Force Physical Fitness Program, airmen must meet the minimum requirements for each fitness component in addition to scoring an overall composite of 75 or higher. For members with a documented DLC which prohibits

them from performing one or more components of the Fitness Assessment, an overall "Pass" rating is required.

REQUIRED DOCUMENTATION FOR APPLICATIONS

All basic qualifications and requirements **MUST** be met by the closing date of the announcement. Incomplete/expired paperwork will **NOT** be considered. Interested applicants must submit the following mandatory documents:

- O-7 Certificate of Eligibility if applicable
- Last 3 OPR's and/or OPB's
- Resume
- Letter of Intent/Cover Letter (optional)
- Recommendation Letter (optional)
