**WHO MAY APPLY: OPEN TO ON-BOARD AGR ENLISTED SOLDIERS WHO HAVE COMPLETED A MINIMUM OF 18 MONTHS OF THEIR INITIAL TOUR, TRADITIONAL M-DAY SOLDIERS OF THE MARYLAND ARMY NATIONAL GUARD.**

<p>1. Must be in a Ready Reserve status.</p> <p>2. If an Enlisted Soldier, must be 18 years of age and not have reached his/her 55<sup>th</sup> birthday.</p> <p>3. Must not be under current suspension of favorable personnel actions.</p> <p>4. Must not be entitled to receive Federal military retired or retainer pay.</p> <p>5. Must be able to complete a 3-year initial tour of AD or FTNGD prior to completing 18 years of active service and before MRD.</p> <p>6. Personnel applying for an initial tour with fifteen (15) or more years of active military duty credited toward retirement must have a waiver from the National Guard Bureau (NGB-ARM) prior to placement on tour.</p> <p>7. Applicants who have voluntarily separated from the AGR Program in lieu of adverse personnel actions, or who have been involuntarily separated from the AGR Program are not eligible to re-enter the program.</p>	<p>1. Must possess the qualifications prescribed in Table 2-1 and not be disqualified under Tables 2-2 or 2-3 IAW AR 135-18.</p> <p>2. Must be medically certified as drug free and be tested negative for HIV within the last 24 months prior to initial entry.</p> <p>3. Must meet the body composition standards prescribed in AR 600-9.</p> <p>4. Must meet the medical fitness standards for retention per AR 40-501, chapter 3; PHA or flight physical must be within 12 months prior to initial entry. Soldiers whose PULHES contains a "3" or "4" must meet the requirements of AR 600-60 prior to initial entry.</p> <p>5. Must be able to complete the Military Education requirements commensurate with the military grade.</p> <p>6. Enlisted Soldiers in grades E6 and above must possess the required grade, MOS and skill level required by AGR duty position (except for detailed recruiting positions) per AR 135-18, Table 2-1(F) 2a: SSG and above not MOSQ may apply, (unless job stipulates otherwise), but must take a reduction to SGT and submit a memo with their application stating they are willing to take a grade reduction to SGT.</p> <p>7. Must be eligible for reenlistment or extension per NGB-ARH Policy #09-26.</p>	<p>1. Must possess the qualifications prescribed in Table 2-4 and not be disqualified under Tables 2-5 or 2-6 IAW AR 135-18.</p> <p>2. Must possess MOS of the AGR duty position or become qualified in that AOC within 12 months.</p> <p>3. Failure to qualify in AGR duty position MOS within 12 months of assignment will result in mandatory separation from the AGR Program per Chapter 6, NGR 600-5.</p> <p>4. Must be within grade requirements of MTOE/TDA position and NGB staffing Guide.</p> <p><b>5. Soldiers who have not completed a minimum of 18 months of their initial tour may request a waiver of the 18 months stabilization rule. <u>through their current Command to be approved by the Chief of Staff (CoS).</u></b></p> <p><b>6. Stabilization Rule waiver consists of:</b> Letter from Soldier, Endorsements from Chain of Command (CoC), SF 52 w/Executive Summary from Command, and original application packet.</p> <p><b>7. A copy of the complete Stabilization Rule waiver along with a copy of the application must reach HRO prior to closing date of the announcement; originals must reach the CoS office prior to the closing date of the announcement.</b></p>

**DESCRIPTION OF DUTIES:** Serves as Brigade Property Book NCO. Duties will consist of managing and assisting the BDE Property Book Officer manage the accountability of all unit equipment and supplies; reviews and evaluates operations and anticipates needs; analyzes data and makes recommendations to ensure accountability; develops budgets and purchases new inventory; maintains an effective supply discipline program; coordinates with Item Managers, Fielding Teams, and other logistic agencies; purchases and maintains supplies; processes and follows up on transactions; schedules and maintains inventories; ensures adequate supplies; collects and returns worn-out and damaged supplies and equipment.

**QUALIFICATIONS REQUIRED:** MOS: 00F30 with feeder MOS 92Y and 92A. Property Book NCO must possess the following qualifications: A physical demands rating of significant (92A) or moderate (92Y). A physical profile of 222222. Qualifying scores: **92A/92Y: A minimum score of 90 in aptitude area CL in Armed Services Vocational aptitude Battery (ASVAB)** on and after 1 July 2004.

Applicant must have or must be able to obtain a SECRET security clearance. Normal color vision. Mandatory formal training. No documented instances in the last 5 years of conduct which reflects adversely on the character, honesty, or integrity of the Soldier to include: (a) No conviction by court-martial or by any Federal or State Court. (b) No juvenile adjudication by state court. (c) No punishment under Article 15, Uniform Code of Military Justice (UCMJ) caused by incidents that reflect adversely on the Soldiers integrity and lack of trust. No letter of reprimand, censure, or admonition under the provisions of AR 600-37, chapter 3.

Voluntary confession after proper rights warning according to Article 31(b), UCMJ, or under applicable Federal or State law. Note: Disqualification under this paragraph is waivable by a military review board. No other record of disciplinary action under UCMJ or pattern of behavior which indicates a lack of trust or integrity or which is inconsistent with the 92Y position of trust. No conviction or other adverse disposition for criminal offenses listed as a misdemeanor or felony as outlined in AR 601-210, chapter 4. This criteria is not waivable.

#### **SPECIAL INFORMATION**

Applicants must have a valid state driver's license and be able to operate military vehicles and equipment organic to the unit. Applicant must have a working knowledge of automated office procedures. Applicant must be able to complete the Military Education requirements commensurate with their military grade. Must not have any flagging actions that would prevent them from applying.

1. Appropriate military uniform will be worn during duty hours.
2. Continuation of tour is subject to findings of the AGR Tour Continuation Board and the Adjutant General.
3. Initial Tour AGR soldiers who do not become MOS/AOC qualified within 12 months will be reassigned to a position for which they are qualified or be separated from the AGR program.
4. Except for mobilization or other emergency, member accepted for tour normally will not be subject to reassignment during the first 18 months of initial tour. After 18 months of initial tour, soldier may be reassigned without consent or without geographical limitations to meet the needs of the service.
5. As a condition of employment, service members are required to attend mandatory PEC training courses associated with their FTS positions. Failure to complete course(s) at PEC within the first year of employment may be cause for reassignment to other FT positions or termination from employment.
6. Must sign a Certificate of Agreement and Understanding prior to being ordered to AGR duty.
