**WHO MAY APPLY: OPEN NATIONWIDE TO ALL AGR ENLISTED SOLDIERS (SPC/E4 – SSG/E6) WHO HAVE COMPLETED A MINIMUM OF 18 MONTHS OF THEIR INITIAL TOUR AND TRADITIONAL SOLDIERS OF THE ARMY NATIONAL GUARD. PCS AUTHORIZATION WILL DEPEND ON THE FUNDING AVAILABILITY OF THE STATE.**

If an Enlisted Soldier, must be 18 years of age and not have reached his/her 55<sup>th</sup> birthday.</li> <li>3. Must not be under current suspension of favorable personnel actions.</li> <li>4. Must not be entitled to receive Federal military retired or retainer pay.</li> <li>5. Must be able to complete a 3-year initial tour of AD or FTNGD prior to completing 18 years of active service and before MRD.</li> <li>6. Personnel applying for an initial tour with fifteen (15) or more years of active military duty credited toward retirement must have a waiver from the National Guard Bureau (NGB-ARM) prior to placement on tour.</li> <li>7. Applicants who have voluntarily separated from the AGR Program in lieu of adverse personnel actions, or who have been involuntarily separated from the AGR Program are not eligible to re-enter the program.</li> </ol>	<ol style="list-style-type: none"> <li>1. Must possess the qualifications prescribed in Table 2-1 and not be disqualified under Tables 2-2 or 2-3 IAW AR 135-18.</li> <li>2. Must be medically certified as drug free and be tested negative for HIV within the last 24 months prior to initial entry.</li> <li>3. Must meet the body composition standards prescribed in AR 600-9.</li> <li>4. Must meet the medical fitness standards for retention per AR 40-501, chapter 3; PHA or flight physical must be within 12 months prior to initial entry. Soldiers whose PULHES contains a "3" or "4" must meet the requirements of AR 600-60 prior to initial entry.</li> <li>5. Must be able to complete the Military Education requirements commensurate with the military grade.</li> <li>6. Enlisted Soldiers in grades E4 and above not DMOSQ may apply, (unless job stipulates otherwise) for MOS required by AGR duty position (except for detailed recruiting positions) per AR 135-18, Table 2-1(F): SFC and above not MOSQ may apply, (unless job stipulates otherwise),but must take a reduction to SSG and submit a memo with their application stating they are willing to take a grade reduction to SSG.</li> <li>7. Must be eligible for reenlistment or extension per NGB-ARH Policy #09-26.</li> </ol>	<ol style="list-style-type: none"> <li>1. Must possess the qualifications prescribed in Table 2-4 and not be disqualified under Tables 2-5 or 2-6 IAW AR 135-18.</li> <li>2. Must possess MOS of the AGR duty position or become qualified in that AOC within 18 months.</li> <li>3. Failure to qualify in AGR duty position MOS within 18 months of assignment may result in mandatory separation from the AGR Program per Chapter 6, NGR 600-5.</li> <li>4. Must be within grade requirements of MTOE/TDA position and NGB staffing Guide.</li> <li><b>5. Soldiers who have not completed a minimum of 18 months of their initial tour may request a waiver of the 18 month stabilization rule through their current Command to be approved by the Chief of Staff (CoS).</b></li> <li><b>6. Stabilization Rule waiver consists of: Letter from Soldier, Endorsements from Chain of Command (CoC), SF 52 w/Executive Summary from Command, and original application packet.</b></li> <li><b>7. **DESCRIPTION OF DUTIES:** Perform cyber-attack; cyber defense; cyber operational preparation of the environment; and cyber intelligence, surveillance, and reconnaissance actions on specified systems and networks. Conduct network terrain audits, penetration testing, basic digital forensics data analysis, and software threat analysis. React to cyberspace events, employ cyberspace defense infrastructure capabilities, collect basic digital forensics data, provide incident response impact assessments, and produce network security posture assessments. Analyze computer system and network architectures, as well as determine and implement exploitation methods. Lead Soldiers in performing activities in support of offensive and defensive cyberspace operations. Validate critical infrastructure configurations, network alerts, and network security posture assessments. Review, write, edit, evaluate and publish both offensive and defensive cyberspace operations products and reports. Perform duties shown in preceding skill levels and provide guidance to subordinate Soldiers. Lead operational teams in support of offensive and defensive cyberspace operations. Conduct cyberspace operations risk assessments, post-incident analysis and intermediate software analysis. Collect and analyze intermediate forensics data. Validate architectural analysis, administer penetration testing, and coordinate response actions.

**QUALIFICATIONS REQUIRED: MOS: 17C Cyber Operations Specialist must possess the following qualifications:** A physical demands rating of Moderate (Gold). A physical profile of 222221. Normal color vision. **A minimum score of 110 in aptitude area GT and a minimum score of 112 in aptitude area ST.** A minimum OPAT score of Standing Long Jump (LJ) – 0120 cm, seated Power Throw (PT) – 0350 cm, Strength Deadlift (SD) – 0120 lbs., and Interval Aerobic Run (IR) – 0036 shuttles Physical Demand Category in “Moderate” (Gold). A high school graduate or equivalent prior to entry on active duty. Never been a member of the U.S. Peace Corps, except as specified in AR 614-200(para 3-2). No information in military personnel, Provost Marshal, intelligence, or medical records that would prevent the granting of a security eligibility under AR 380-67 (para 3.401.a). No record of conviction by court-martial. No record of conviction by a civil court for any offense other than minor traffic violations. Must be a U.S. citizen. The Soldier must meet TOP SECRET (TS) Sensitive Compartmented Information (SCI) access eligibility requirements to be awarded and maintain the MOS. The clearance requirement to begin training is an Interim TS/SCI reflected within DISS or current SSBI with TS/SCI eligibility reflected within DISS. A fully adjudicated TS/SCI (SI/TK/G/HCS) reflected within DISS will be required to complete training. Soldiers cannot hold this MOS if they have immediate family members (includes both blood and step: spouse, parents, siblings, children, any sole living blood relative, cohabitant of the individual, or a person in loco parentis per AR 600-8-10) who are citizens or dual-citizens, or reside in one of the countries on the U.S. Army Tiered Country List. Waiver requests must be coordinated with the Cyber Center of Excellence, Personnel Security Office. Have neither commercial nor vested interest in a country within whose boundaries physical or mental coercion is known to be a common practice against persons acting in the interest of the U.S. This requirement applies to the Soldier's spouse as well. Due to the nature of training and assignments, temporary restrictions may be placed on foreign travel both during and after the term of service. Soldier must be capable of passing a counterintelligence scope polygraph (CSP) at any time to hold this MOS. Soldiers who refuse to take or fail a CSP will be reclassified. **Formal Training (successful completion of 17C Cyber Operations Specialist Course, conducted under the auspices of the US Army Cyber School) is mandatory. Constructive credit for formal training and/or operational experience may be granted by Commandant, US Army Cyber School. The Service Remaining Requirement (SRR) for reclassification into MOS 17C under the provisions of AR 614-200, Chapter 4 is 3 years, which will begin upon completion of all required training.**

#### SPECIAL INFORMATION

1. Appropriate military uniform will be worn during duty hours.
2. Continuation of tour is subject to findings of the AGR Tour Continuation Board and the Adjutant General.
3. Initial Tour AGR soldiers who do not become MOS/AOC qualified within 18 months may be reassigned to a position for which they are qualified or be separated from the AGR program.
4. Except for mobilization or other emergency, member accepted for tour normally will not be subject to reassignment during the first 18 months of initial tour. After 18 months of initial tour, soldier may be reassigned without consent or without geographical limitations to meet the needs of the service.
5. As a condition of employment, service members are required to attend mandatory PEC training courses associated with their FTS positions. Failure to complete course(s) at PEC within the first year of employment may be cause for reassignment to other FT positions or termination from employment.
6. Must sign a Certificate of Agreement and Understanding prior to being ordered to AGR duty.
7. Applicant will receive PCS entitlements if applicable as a result of reassignment to a new permanent duty station (PDS). Applicant must relocate to a residence within the local commuting area of the new PDS in order to be eligible for PCS entitlements.
