WHO MAY APPLY: Open to nationwide officers, traditional officers and Title 10 or 32 AGR officers eligible for service with the Maryland Army National Guard in the grades of O3.

DESCRIPTION OF DUTIES: C/2-224 Assault Helicopter Company (AHC) commander, responsible for the tactical deployment and training of 10 UH-60A/L/V Black Hawks, flight crews and Detachment 1 D/2-224 unit level maintenance. Serves as the Aircrew Training Program (ATP) commander, responsible for the technical and tactical training of 44 rated and nonrated crew members. Manages missions specialized in the air assault and associated Mission Essential Task List (METL) in preparation for CONUS and OCONUS missions. Performs duty as Pilot (PI) / Pilot in Command (PC) under day, night, Night Vision Goggle (NVG) and Instrument Meteorological Conditions (IMC).

REQUIRED QUALIFICATIONS: Must be in the grade of CPT (O3). Must possess or be able to possess a security clearance of Secret.

### SPECIAL INFORMATION

Position is not gender restricted. Assignment limitations of NGR 600-100 apply. This is an aviation flight operational duty assignment and requires a medical up slip. Consideration will be given to personnel that are or previously served as a Pilot-In-Command for all current Mission Design Series (MDS). Must be enrolled or complete with Advance Operations Course (AOC).
