WHO MAY APPLY: **Open to traditional MDAY Soldiers, on board T32/T10 NCOs who have served and been rated as a BN MSG or any Company-Level SFC. Applicants must be a current or previous SFC or MSG or listed on the MDARNG 1SG BQ List. This is a traditional M-Day position.**

DESCRIPTION OF DUTIES: **The Aviation First Sergeant acts as the advisor to the company commander, Platoon and Section echelon, supervises aviation company level operations and training; is the Aircraft Maintenance Senior Sergeant in a maintenance company/troop, aviation support company/troop or depot maintenance facility, provides tactical and technical guidance and professional support to subordinates, and makes recommendations to supervisors in the accomplishment of their duties. 1SGs should also have expertise in executing Flight Operations, Aircraft Maintenance Operations, Unit Training Management (UTM) and related systems such as Army Training Network (ATN), Digital Training Management System (DTMS), and the Combined Arms Training Strategies (CATS) Development Tool.**

REQUIRED QUALIFICATIONS: **Must hold the 15Z CMF. Must hold a Secret clearance. Must meet the physical requirements of AR 350-1, AR 600-9, and AR 40-502. Applicant must not be currently under suspension of favorable personnel actions. Must be in grade of E8 or a promotable SFC/E7 at the time of selection. Should have extensive experience in CMF 15Z with thorough understanding and knowledge of flight training, maintenance training (AMTP), organizational principles, policies, regulations, and operations. Must possess an in-depth knowledge of the mission of the 29<sup>th</sup> Expeditionary Combat Aviation Brigade.**
