WHO MAY APPLY: Open to traditional MDAY Soldiers, on board T32/T10 NCOs holding the immaterial Logistics (00L) position which is interchangeable between logistics career management fields 88 (Transportation), 89 (Ammunition), 91 (Ordnance) and 92 (Quartermaster), 94 (Electronic Maintenance and Calibrations); and those who are currently on the MDARNG CSM BQ List. Additionally, all previous CSMs holding the ASI "6C" are eligible to apply. This is a traditional M-Day position.

DESCRIPTION OF DUTIES: The 1297th Combat Sustainment Support Battalion (CSSB) Command Sergeant Major acts as the principal advisor to the Battalion Commander (BC). They are the senior Noncommissioned Officer within the Logistics Battalion and as such, they advise the BC on all enlisted matters. The CSSB is comprised of the Headquarters and Headquarters Company, 1729th Support Maintenance Company, 1229th Transportation Company, 911th Field Feeding Platoon, and the 729th Composite Supply Company. This individual will be a subject matter expert on all things logistics. The CSM should work on helping the Senior NCOs develop organizational leadership skills needed to coach, teach, and mentor Soldiers. They are responsible for the health, discipline, morale, welfare of the entire CSSB. They serve as the Senior Enlisted Trainer and work in conjunction with the unit First Sergeants and is instrumental in coaching, mentoring, and developing on the enlisted assignments within the Battalion.

REQUIRED QUALIFICATIONS : Must hold the 00L CMF or ASI "6C". Must hold a Secret clearance. Must meet the physical requirements of AR 350-15, AR 600-9, and AR 40-502. Applicant must not be currently under suspension of favorable personnel actions. Must be in grade of SGM/E9 or a promotable MSG/E8 at the time of selection. Must have extensive experience in CMF 00L, with thorough understanding and knowledge of Logistic principles, policies, regulations, operations, and organization. Must possess an in-depth knowledge of the organization and mission of the 1297th Combat Sustainment Support Battalion.
