WHO MAY APPLY: **Open to all traditional (M-Day) and Title 32 AGR Maryland Army National Guard officers or those eligible for membership, holding the Aviation branch and either in the grade/rank of O6/COL or O5/LTC who are eligible for promotion to O6/COL at the time of selection. Applicants must also possess all required qualifications listed below.**

DESCRIPTION OF DUTIES: Commands a Combat Aviation Brigade (CAB) supporting 29th Infantry Division, XVIII Airborne Corps. Exercises Mission Command to provide all types of aviation support in unified land operations and other missions including attack aviation, air assault operations, aerial movement, aerial resupply, aeromedical evacuation, unmanned aircraft operations, aviation maintenance and sustainment, airfield management, and air traffic services. Assesses, tracks, and manages unit readiness, providing command guidance and priorities to ensure personnel, training, and equipment readiness objectives are achieved. Maintains readiness to provide humanitarian relief and other support to civil authorities as directed. Responsible for Commander's Safety Program as well as EO, EEO & SHARP programs.

REQUIRED QUALIFICATIONS: Must have prior battalion level command experience. Must have completed Intermediate Level Education (ILE) Common Core and the Advanced Operations Course or have completed the equivalent Military Education Level to be ILE Complete. Must hold the G9 (Multi-Aircraft Aviation Officer) Additional Skill Identifier. Must hold a current Secret clearance. Must meet the physical requirements of AR 350-15, AR 600-9, and AR 40-501. Must not be currently under suspension of favorable personnel actions.

1. Military Resume (Biographical Summary) in accordance with format in Appendix H, NGR 600-100.
2. Three most current available OERs and any other OERs relating to battalion command time.
3. Officer Record Brief (ORB).
4. Personnel Qualifications Record (PQR).
5. DA Form 705 (APFT Scorecard) within 12 months of the board date. A physical profile may be submitted in lieu of APFT record.
6. Height-Weight Statements within 6 months of the board date. DA Form 5500-R/5501-R must be included if soldier exceeds authorized screening table weight of AR 600-9.
7. Optional applicant memorandum to provide additional information to the president of the selection board not contained in the above listed documents.

All applications will be screened without regard to ethnicity, religion, gender or national origin. Selection will be made the basis of military education, skills and individual experience.
