WHO MAY APPLY: Open to traditional MDAY Soldiers, on board T32/T10 NCOs holding the Mechanical Maintenance (91Z) MOS and MSG or SFC listed on the MDARNG 1SG BQ List. All T32 (AGR) Applicants must already be in the Grade of E8 at the time of selection. Additionally, all previous 1SG's are eligible to apply. This is a traditional M-Day position.

DESCRIPTION OF DUTIES: The First Sergeant of the 128th BSB HCO serves as the principal advisor to the Commander on matters concerning enlisted Soldiers. This includes overseeing duty assignments, promotions, military justice, awards, morale, welfare, professional development, and equal opportunity. The First Sergeant is responsible for supervising, planning, and directing the sustainment maintenance of all wheeled armament, power generation, and utility equipment. The 128th BSB HCO provides support through its Maintenance Platoon, Distribution Platoon, and Food Service Section. Additionally, the First Sergeant assists the Commander in planning, coordinating, and supervising all logistical operations that support the Squadron's missions.

REQUIRED QUALIFICATIONS: Must hold the 91Z MOS. Must hold a Secret clearance. Must meet the physical requirements of AR 350-15, AR 600-9, and AR 40-502. Applicant must not be currently under suspension of favorable personnel actions. Must be in grade of E8 or a promotable E7 at the time of selection. Must have extensive experience in CMF91, with thorough understanding and knowledge of Mechanical Maintenance principles, policies, regulations, operations, and organization. Must possess an in-depth knowledge of the organization and mission of the 128th BSB HCO.
