The training center provides year-round customer service through administrative, engineering, logistical, training and operational support to assigned, attached, transient, or tenant units and joint forces activities for company sized units. They are the principal Noncommissioned Officer within the Garrison Training Center and as such, they advise the Commander on all enlisted matters. The 1SG should work on helping the Senior NCOs develop organizational leadership skills needed to coach, teach, and mentor Soldiers. They are responsible for the health, discipline, morale, and welfare of the entire Training Center. They serve as the Senior Enlisted Trainer and work in conjunction with the Section Sergeants. They should be able to communicate effectively and tactfully with the senior leadership of the Organization. They are instrumental in coaching, mentoring, and developing the enlisted soldiers within the Training Center.

REQUIRED QUALIFICATIONS:

Must hold a Secret clearance. Must meet the physical requirements of AR 350-15, AR 600-9, and AR 40-502. Applicants must not be currently under suspension of favorable personnel actions.
