WHO MAY APPLY: Open to all on board T10/T32 MDARNG E9 NCOs listed on the MDARNG CSM BQ List. Open to traditional MDAY Soldiers, on board T32/T10 NCOs for MOS 18Z position. Applicants must be on the current CSM Best Qualified List from their respective state. All T32 (AGR) applicants must already be in the Grade of E9 at the time of selection. Additionally, all previous CSMs are eligible to apply. This is a traditional M-Day position. You are required to be a member of Maryland Army National Guard if selected for this position. Candidates must submit an Interstate Transfer (IST) packet if the selected NCO is assigned to another state. Upon completion of the term, it will be the sourcing state's responsibility to place the candidate (reassignment, IST, Individual Ready Reserve (IRR), retirement, etc.). Assignments will not exceed 36 months unless the selected Soldier mobilizes with the gaining unit or decides to remain in the MDARNG.

DESCRIPTION OF DUTIES: Serves as the Special Operations Command Senior Enlisted Leader for a Joint Theater-Level Special Operations Detachment providing command and control (C2), staff integration, and synchronization of combined joint special operations forces. Serves as the senior enlisted advisor to the CDR and staff on all matters pertaining to enlisted Soldiers and their families; is responsible for enforcing established policies and standards for enlisted Soldiers pertaining to performance, care, conduct, appearance, effective personnel utilization, management and training. Ensures adherence to command policies and military discipline. Inspects performance of subordinate Noncommissioned Officers and mentors as appropriate. Advocates for Soldiers and their families in the command.

REQUIRED QUALIFICATIONS: Must be Special Forces qualified and have completed USASMA / JSOFSEA at the time of selection. Must hold a Top Secret/SCI clearance. Must meet the physical requirements of AR 350-15, AR 600-9, and AR 40-501. Applicant must not be currently under suspension of favorable personnel actions. Must have successfully served in previous senior level Special Forces enlisted positions without reprimand or issues. Must render excellent writing and speaking ability. Must have extensive experience in CMF 18 Series, a minimum of Sergeant Major experience ASI 6S is required with thorough understanding and knowledge of Army Special Forces principles, policies, regulations, operations, and organization to include staff level experience in multinational and joint command environments. Must possess an in-depth knowledge of the entire organization and mission of USASOC, ARNG SOF assets and NATO Special Operations.
